The following information will guide you through the application process. International applicants must meet the admission requirements to the College as explained in the following section.

APPLICATION CHECKLIST: International students must submit the following:

- A completed Mt Sierra College International Student application for admission form
- Application fee: \$150 USD (Non-refundable)
- Registration fee: \$100 USD (Non-refundable)
- Official high school transcript and a color copy of diploma: Official high school transcript or equivalent indicate a GPA of 2.25 or higher (Foreign high school transcript and diploma: English translation required)
- Official college/university transcript and a color copy of diploma (if applicable): Official College/University transcript or equivalent (Foreign College/University transcript and diploma: English translation and foreign transcript required)
- Passport
- VISA/I-94 form: For transfer students only
- All I-20 forms from previous schools attended in the U.S.
- Statement of financial support: Official document of financial support demonstrating a minimum of \$49,500 USD in available funds
- Proof of English proficiency

Fee Refund policy: Applicants who have not yet attended class have the right to cancel the enrollment agreement at any time. Applicants who have attended class retain the right to cancel the enrollment agreement through attendance at the first class session or midnight of the seventh calendar day after enrollment, whichever is later. "Attended" is defined as attendance in the classroom or participation in an online course "Enrollment" is defined as execution of an enrollment agreement.

- ▶ If a Notice of Cancellation is submitted prior to midnight of the third business day following the date the enrollment agreement was signed, the applicant will receive a refund of all monies paid, except the non-refundable fees (Application & Registration Fees).
- ▶ If a Notice of Cancellation is submitted following this period, but no later than through attendance at the first class session or midnight of the seventh calendar day after enrollment, whichever is later, the applicant will receive a refund of all monies paid, except the non-refundable fees (Application & Registration Fees).

The College will issue all refunds within forty-five days of the date the notification of cancellation received by the Registrar. Applicants who are denied admission to the College will receive a refund of the registration fees within forty-five days of the date of determination of admission.

English Language Proficiency can be demonstrated by one (1) of the following:

- ▶ TOEFL: score of 477 PBT, 53 IBT
- ▶ IELTS: score of 5.0 or higher
- ▶ iTEP: score of 3.4 or higher
- ▶ Bertliz: Level 6
- ▶ Pearson Test of English (PTE) academic score of 52
- ▶ Official transcript from an accredited program certifying successful completion of an advanced English as a Second Language (ESL) program.
- ▶ An official transcript showing completion of a minimum of 18 quarter credit hours of substantive undergraduate level academic courses with a CGPA of 2.25 or higher at an accredited postsecondary institution where English was the language of instruction.
- ▶ Graduation from a foreign high school where English is the language of instruction.
- ▶ An official transcript showing successful completion of the Advanced Placement International English Language (APIEL) exam with a minimum score of 3
